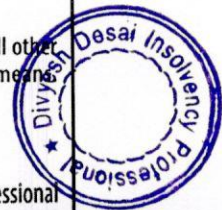
The submission of proof of claims is to be by way of the following specified forms and documentary proof in support of claim in
